That is why I use the PAR (Pre-Authorized Remittances) plan to fulfill my commitment.”

If you have automatic cheques going to your bank account to pay for insurance, taxes, fuel or mortgage, then you understand the PAR principal. For both Knox Church and you PAR means regular contributions throughout the year.

Many people in other churches use the PAR plan for their church offering, finding it a convenient way to take care of their regular commitments to the church month by month. Now you can participate in this program at Knox Church.

On or about the 20th of each month your bank account will be debited with your monthly gift, and our congregation’s bank account will be credited with the total of all gifts from those who participate in this plan.

Should you wish to change your contribution, either in amount or distribution, simply notify Kevin Pasma, Chief Administrative Officer & Treasurer at Knox Church, by way of letter, note or email.

Changes received prior to the 1st of the month become effective on the 20th of the same month.

Advantages to the Contributor:

1. Regular support of the church in the amount that you choose.
2. Continual support of the church when you are away.
3. Avoidance of “catch-up” periods.
4. Can reduce the number of transactions through your bank account.

Advantages to the Congregation:

1. Regular, dependable flow of contributions.
2. Reduction of paper work and bookkeeping.

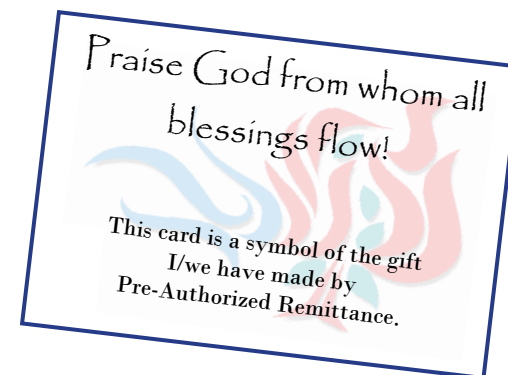
It’s easy to participate in the PAR plan.

All you have to do is:

1. Decide the amount of your monthly offering. If you usually give a certain amount weekly, please remember there are 4.33, not 4 weeks in a month. A Monthly Givings Calculator is shown on the opposite page to help you calculate the monthly amount.
2. Complete the PAR Authorization Form section in this brochure and attach a sample cheque from your bank account marked “VOID.”
3. Enclose both in an envelope addressed to Kevin Pasma, Chief Administrative Officer & Treasurer, and place on the offering plate or leave it at or mail to Knox Church.
4. Once you are signed up, we will send you a confirmation letter and a supply of PAR cards for you to put into the offering plate each Sunday as a symbol of your giving.

We worship God with our offering

Each Sunday you may place a card, which we will supply to you, in the offering as a symbol of your giving.

Example: a weekly gift of \$50 would be a monthly gift through the PAR plan of \$217.
